MONTHLY NEWS AND INFORMATION FROM YOUR RETIREMENT BOARD

RETIREE HEALTHCARE – CITY PROVIDED HEALTH INSURANCE PLANS

Members of CFD that are retiring and staying in any City of Chicago Health Insurance Plan should note, the Firemen's Annuity and Benefit Fund of Chicago ("Fund") is not the insurance provider at retirement, it simply facilitates insurance premium payments to the City of Chicago ("City"). The City remains as the insurance provider for any City Health Insurance Plan offered to retirees. The Fund is not involved in the enrollment process other than as a courtesy to the City. The Fund currently has members sign the City's insurance enrollment form and then forwards that form to the City of Chicago Benefits Management Office.

The Fund has no control over when the City updates member status from active to retired, when BlueCross/BlueShield of Illinois is notified or when new cards are sent out. Also, the Fund does not have any knowledge of the specific plan or coverage maintained by retirees. All insurance questions should be directed to the City's Benefits Service Center at (877) 299-5111. A benefits portal is also available online through the city for retirees.

RETIREE HEALTHCARE - MEDICARE AND THIRD PARY PROVIDERS

There are other group health insurance plans offered by third parties to Fund retirees no longer in the City of Chicago Health Insurance Plan. The Fund does not solicit or endorse any group health insurance plan, nor does it host or participate in the enrollment process. The Fund only supports the completion of the required deduction authorization form and withholds premiums as instructed by the member, which it then directs to the respective approved group retiree health insurance provider. Additionally, the Fund does not receive any notice or have knowledge regarding changes in a member's coverage or premium amount.

RECIPROCITY

What is system reciprocity? The Illinois Retirement Systems Reciprocal Act gives retiring Illinois public employees the option to utilize all service credit earned toward a benefit calculated based upon combined pension service between participating Systems. Each System uses the member's highest earnings when it calculates a pension. A website and fact sheet for participating public retirement systems can be found at: Retirement Systems Reciprocal Act. Chicago police and fire and downstate police and fire Funds do not participate in the Reciprocal Act. You may have read about possible legislation which may amend the Act to allow police and fire employees to participate with the reciprocal Systems. Legislation aimed at allowing for such reciprocity has been introduced but is pending in the spring legislative session.

CITY OF CHICAGO MAKES ADDITIONAL PAYMENT TO FUND

Some members are aware and have had questions regarding the additional employer contributions received by the Fund in 2023 and 2024. As I stated in the December letter, the Fund received \$399,860,000 for the year ending 2023 from the City of Chicago. That amount satisfied all statutory actuarial required employer contributions due & owing to the Fund for 2023. The City contributed in January of 2023 an additional payment of \$38.72 million allocated from the 2023 budget year and that payment was separate from, and in addition to, the statutorily required amount. In January of 2024 the Fund received a similar additional employer contribution of \$28.27 million allocated from the 2024 budget year which is separate from, and in addition to, the City's statutorily required contribution due and owing of \$429,101,178 for payment year 2024.

DOWNSTATE PENSION FUND CONSOLIDATION

The Supreme Court recently affirmed the lower Court's opinion to allow the hundreds of downstate police and fire pension funds to consolidate their investments into two investment funds. Neither the consolidation legislation nor the Supreme Court ruling impacted the Chicago Funds, including ours. However, there were several conclusions expressed by the Court that may influence future legislation.

It is important to remember:

YOUR RIGHTS UNDER THE ILLINOIS CONSTITUTION ARTICLE XIII - GENERAL PROVISIONS - SECTION 5. PENSION AND RETIREMENT RIGHTS "Membership in any pension or retirement system of the State, any unit of local government or school district, or any agency or instrumentality thereof, shall be an enforceable contractual relationship, the benefits of which shall not be diminished or impaired."
