FIREMEN'S MUTUAL AID & BENEFIT ASSOCIATION

The Firemen's Mutual Aid & Benefit Association is a non-profit life insurance company which services the Chicago Fire Department firefighters, paramedics, and their families.

They are trying to reach Chicago Fire Department retirees and active members that have policies with them, who have moved or relocated in order to disburse dividends or death benefits to beneficiaries.

SECURE ACT 2.0

Prior to the holidays, the historically largest package of federal tax law changes for retirement plans was passed. SECURE 2.0 includes several provisions, and impacts virtually all aspects of retirement savings for American workers. [NCPERS Secure Act Overview](#).

Of particular interest to our members is the continuation of the deductibility of up to \$3,000 of distributions from a governmental retirement plan to pay for health insurance premiums. SECURE 2.0 repeals the current requirement that payment be made from a governmental retirement plan and allows payments to be made directly by the retiree.

The impact and benefits of this comprehensive Act are being reviewed and future guidance will be provided as we learn more.

HEALTHCARE UPDATE FOR 2023

Similar to 2022, there are currently two group health insurance plans that are offered to Fund retirees in 2023. Both retiree healthcare plan options require the Fund to collect and forward authorized payment of premiums from your benefit check to the selected healthcare plan to ensure that eligible participants receive the statutory subsidy required under the Illinois Pension Code.

If you are interested in enrolling in one of these two group plans, please contact the specific healthcare plans at the following numbers: (1) for the City's BCBS plan call 1-877-566-8520 if you are over 65 years of age; if you are under 65 years of age, please call 1-800-292-6398; or (2) for Local's 2 Aetna Plan, please contact Labor First through its website at [Laborfirst](#). Any member currently enrolled in one of these plans already has an authorization form on file at the Fund for the deduction and would only need to contact the Fund if they disenroll from their plan.

Any new enrollments will require a valid "Participation Authorization for the Payment and Pre-Tax Treatment of Healthcare Premiums" be on file with the Fund before any health premium deduction can be made.

MEMBER SERVICE ENHANCEMENT


