MONTHLY NEWS AND INFORMATION FROM YOUR RETIREMENT BOARD

RETIREE MINIMUM ANNUITY INCREASED

The Firemen's Annuity and Benefit Fund of Chicago Retirement Board voted at the February 2023 meeting to approve a statutory increase to the minimum retired annuity benefit consistent with the requirements of the Illinois Pension Code. The Minimum Retiree Annuity benefit is to be no less than 125% of the Federal Poverty Level. Starting with their February payment, affected members will see their monthly annuity increase for the next twelve months by an amount up to \$103.12 monthly. The increase is based on 125% of the January 2023 Federal Poverty Level applied to each affected member's original annuity amount.

WIDOW MINIMUM ANNUITY INCREASED

Also, at the February meeting, the Board voted to approve a new policy recognizing the statutory increase to the minimum widow annuity benefit created by the passage of Public Act 102-0884. The legislation increased the Minimum Widow's Annuity benefit to no less than 150% of the Federal Poverty Level. The legislation became effective January 1, 2023.

Therefore, the Fund is providing a retroactive distribution for the month of January based on 150% of the January 2022 Federal Register level. Affected widows will receive retroactive payment representing the additional amount due for January 2023. This will be a separate distribution from each affected member's February annuity payment. The new monthly annuity amount will increase for the next twelve months to no less than \$1,822.50 monthly based on 150% of the January 2023 Federal Poverty Level.

Members may want to consider thanking Local 2 for its successful efforts in getting the monthly Minimum Annuity amounts raised for our most economically vulnerable Retirees and Widows.
