YOUR RIGHTS UNDER THE ILLINOIS CONSITUTION ARTICLE XIII GENERAL PROVISIONS - SECTION 5. PENSION AND RETIREMENT RIGHTS

"Membership in any pension or retirement system of the State, any unit of local government or school district, or any agency or instrumentality thereof, shall be an enforceable contractual relationship, the benefits of which shall not be diminished or impaired."

LEGISLATIVE UPDATE

There are several bills being considered by the Illinois Legislature that may impact the membership. Many of these bills contemplate changes affecting members hired after January 1, 2011 (Tier 2). This initiative is part of a broader legislative review of Social Security Safe Harbor provisions and what (if any) changes may be necessary to assure future compliance to maintain the City of Chicago's exemption from Social Security contribution requirements.

One item under scrutiny is the current wage cap applicable to Article 6 Tier 2 members; the current salary cap for 2024 is \$125,773.73. Downstate public safety plans were able to secure higher cap limits during the consolidation process. In addition, Cook County employees were provided a salary cap increase equivalent to the Social Security Wage Base (SSWB) earlier in the session. It is anticipated some movement in this area will be forthcoming. However, the prevailing opinion is that pension legislation will be held until after the fall election. It will be a hectic Veto Session! An overview summary of the benefit structures affecting the membership follows under the title "Tier 1 and Tier 2 Benefit Comparison".
