MONTHLY NEWS AND INFORMATION FROM YOUR RETIREMENT BOARD

FIREFIGHTER CONTRACT UPDATE

As of the date of this letter, the labor agreement between IAFF Local 2 and the City of Chicago is still being negotiated. The existing contract dated July 1, 2017 through June 30, 2021, is still in force. Should a new contract be ratified, and the language supports the recalculation of benefits granted to members who have (or will retire) during the open window, the Fund will communicate with those members affected on the amount and timing of benefit adjustments that may be warranted. Fund staff does not have any information regarding the timing of the ratification process. Please contact Local 2 directly if you have questions or concerns on this issue.

LEGISLATIVE UPDATE

Under new legislation sent to Governor Pritzker on Wednesday, May 16, 2024, HB5104, the period during which a firefighter may be eligible to prove a disability due to COVID 19 has been extended from the date established in the previous COVID related bill- HB3162 (PA 103-0002). Upon the Governor signing the bill, the exposure and contraction period for a presumption that the COVID disability was duty related must be documented to have occurred in the period between March 9, 2020, through (NEW DATE) January 31, 2022, provided, the presumption does not apply if the fireman was on a leave of absence or otherwise not required to report for duty for a period of 14 or more consecutive days immediately prior to the date of contraction of Covid-19. The bill will become effective immediately, should it be signed.

As many of you are aware, several bills still pending in both the House and Senate may affect our membership, including Tier 2 members. It is still anticipated some movement regarding Tier 2 members' benefits will be forthcoming. However, with the adjournment deadline of May 31, all action regarding these and other pending bills will be held until after the election and during the late fall, early January, veto session.
